ORDER

The Syndicate at its meeting held on 16.07.2021 and 18.08.2021 had considered the recommendations of the Monitoring Committee meeting for Autonomous Colleges held on 25.06.2021, in tune with the University Laws (Amendment) (No.2) Ordinance 2021 and resolved vide item no.2021.577* (emended item No. 2021.637*) to levy one time Affiliation fee from the Autonomous Colleges for all programmes except for those with permanent affiliation as follows:

- Aided UG programmes-at the rate of Rs. 5515 per year for a period of 6 years, which amounts to a total of Rs. 33,090/- (5515x6).
- Aided PG programmes-at the rate of Rs.5515 per year for a period of 4 years, which amounts to a total of Rs. 22,060/- (5515x4).
- Self-financing UG programmes- at the rate of Rs.20,000/- per year for a period of 6 years, which amounts to a total of Rs. 1,20,000/- (20,000x6).
- Self-financing PG programmes- at the rate of Rs.25,000/- per year for a period of 4 years, which amounts to a total of Rs. 1,00,000/- (25,000x4).

The aforesaid decisions of the Syndicate were implemented, vide University Order read as first and second.

2. Accordingly, in tune with the circular read as third above, the Principal, St. Joseph's College (Autonomous), Devagiri, Kozhikode was requested, vide paper read as fourth, to submit application for One Time Affiliation to the programmes for which Continuation of Provisional Affiliation is annually renewed. Principal has submitted the application after remitting the required fee of ₹10,41,325 (Ten Lakh forty one thousand three Hundred twenty five only) towards One time affiliation fee and fine (₹11,025) for 12 programmes as detailed in the table below, vide paper read as fifth above.

3. Besides, as per the clause 3.5 of UGC (conferment of autonomous status upon colleges and measures for maintenance of standards in autonomous colleges) Regulations 2018 that the autonomous colleges need not pay affiliation fee to the parent University every year. One time fee can be paid at the time of conferment of autonomous status. Such fee can be decided by the executive council of the parent University. As per the Amendment of University Laws Act 68 PA (9) the Autonomous College shall pay one time affiliation fee and such other amount to the University at the time of conferment or extension of autonomous status in accordance with the provisions contained in this Chapter.

4. Considering the matter in detail, the Vice Chancellor has accorded sanction to place the matter before the Syndicate.

5. The meeting of the Syndicate held on 13.04.2023 has considered the matter, vide item No. 2023.396* and approved as per rule for granting One Time Affiliation from the academic year 2022-23 onwards to the programmes for which Continuation of Provisional Affiliation has been granted till the academic year 2021-22 at St. Joseph's College (Autonomous), Devagiri, Kozhikode

6. Sanction has been accorded by the Vice Chancellor to implement the above said resolution of the Syndicate.

7. Orders are, therefore, issued granting One Time Affiliation to the following programmes for which Continuation of Provisional Affiliation has been granted till the academic year 2021-22 at St. Joseph's College (Autonomous), Devagiri, Kozhikode from the academic year 2022-23 onwards as detailed below, implementing the aforesaid resolution of the Syndicate, subject to the terms and conditions thereunder.

iv) The conduct of University examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

 v) The complementary courses/common courses are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
vi) Violation of any of the above may lead to the cancellation of affiliation.

The self financing programmes B.Com Honours (60), BA Animation and Graphic Design (50), B.Sc Honours in Mathematics (48), B.Sc Computer Science and Mathematics (Double Main) (36), Bachelor of Sports Management (50), started w.e.f the academic year 2022-23 at St. Joseph's College (Autonomous), Devagiri, Kozhikode, were regularised, vide University Order read as third.

2. One Time Affiliation fee will be levied from Autonomous colleges for all programmes except for those with permanent affiliation as per University order read as first.

3. As per the Amendment of University Laws Act 68 PA (9), the Autonomous College shall pay one time affiliation fee and such other amount to the University at the time of conferment or extension of autonomous status in accordance with the provisions contained in this Chapter.

4. Vide paper read as fourth, the Principal has submitted an application for one time affiliation for the self financing programmes B.Com Honours (60), BA Animation and Graphic Design (50), B.Sc Honours in Mathematics (48), B.Sc Computer Science and Mathematics (Double Main) (36), Bachelor of Sports Management (50) in tune with the circular read as second.

5. Considering the matter in detail, the Vice Chancellor has accorded sanction to place the matter before the Syndicate.

6. The meeting of the Syndicate held on 30.12.2024 has considered the matter, vide paper read as fifth and approved the request for granting One Time Affiliation to the self financing programmes B.Com Honours (60), BAAnimation and Graphic Design (50), B.Sc Honours in Mathematics (48), B.Sc Computer Science and Mathematics (Double Main) (36), Bachelor of Sports Management (50) w.e.f the academic year 2022-23 at St. Joseph's College (Autonomous), Devagiri, Kozhikode.

<u>ORDER</u>

The Syndicate in its meeting held on 16.07.2021 and 18.08.2021 had considered the recommendations of the Monitoring Committee meeting for Autonomous Colleges held on 25.06.2021,in tune with the University Laws(Amendment)(No.2) Ordinance 2021 and resolved vide item no.2021.577* & emended item no.2021.637*, to regularize the programmes that have been already started in the Autonomous colleges upholding the UGC Regulations 2018, but without following the statutory provisions of the University after conducting inspection, collecting affiliation fee for each programme applying the rate of one time affiliation fee as mentioned below:

- Aided UG programmes- at the rate of Rs.5515 per year for a period of 6 years, which amounts to a total of Rs. 33,090/- (5515x6).
- Aided PG programmes- at the rate of Rs.5515 per year for a period of 4 years, which amounts to a total of Rs. 22,060/- (5515x4).
- self-financing UG programmes- at the rate of Rs.20,000/- per year for a period of 6 years, which amounts to a total of Rs. 1,20,000/- (20,000x6).
- Self-financing PG programmes- at the rate of Rs.25,000/- per year for a period of 4 years, which amounts to a total of Rs. 1,00,000/- (25,000x4).

The aforesaid decisions of the Syndicate were implemented vide University Order read as first and second above.

2. The Principal, St.Joseph's College (Autonomous), Devagiri, Kozhikode has requested, vide paper read as third above, to regularize the affiliation of programmes that have already started upholding the UGC Regulations, but without following the statutory provisions of the University. Vide paper read as fourth above, Principal was requested to submit the complete details of the programmes already started in the College without following the statutory provisions of the University.

3. Subsequently, Principal, St.Joseph's College (Autonomous), Devagiri, Kozhikode, vide paper read as fifth above, has forwarded the details of the programmes that have been already started upholding the UGC regulations 2018,but without following the statutory provisions of the University as detailed below.

4. Principal has remitted one time affiliation fee of ₹6,80.000/- (Rupees Six lakh Eighty Thousand only) vide chalan numbers 202041351 dated 04.11.2020 , 202234560 dated 10.12.2020 and 2212870000 dated 16.03.2022 as part of regularizing the programmes .

5. A special Inspection Committee has been constituted for conducting inspection at Autonomous Colleges as part of regularizing the affiliation of the programmes that have been already started upholding the UGC Regulations, but without following the statutory provisions of the University, vide University orders read as sixth and seventh above.

6. Special Inspection Committee has conducted inspection at St.Joseph's College (Autonomous), Devagiri, Kozhikode on 17.05.2022, and has evaluated that the College has sufficient academic, infrastructural facilities, practical and lab facilities for the smooth conduct of programmes. In addition, the college has set apart well furnished class rooms for the new programmes. Besides, the college have basic amenities like toilets, sick rooms, drinking water facilities etc and library with good collection of books and journals. College also provide net connectivity to students and sufficient computer facilities. The Committee has evaluated that the college is having all necessary requirements to run the above mentioned self financing programmes and recommended to regularize the affiliation of the aforesaid programmes which are started from the academic years 2019-20 and 2020-21.

7. Subsequently, the Inspection report submitted by the Special Inspection committee recommending the regularization of affiliation of self financing programmes, that have been already started at St.Joseph's College (Autonomous), Devagiri, Kozhikode upholding the UGC Regulations 2018, but without following the statutory provisions of the University, was placed before Syndicate for consideration.

8. The meeting of the Syndicate held on 15.07.2022 has considered the matter vide item No 2022.770* and approved the inspection report submitted by the Special Inspection Committee, recommending regularization of affiliation of self financing programmes BA English Language and Literature (40), B.Com Finance (60), B.Com Professional (60), MSW (Batch II) (20) which are started during 2019 -20 and BBA (Honors) (50), & M.Sc Computer Science (12) which are started during 2020 -21 at St. Joseph's College (Autonomous), Devagiri, Kozhikode, upholding the UGC Regulations 2018, but without following the statutory provisions of the University.

9. Considering the above, sanction has been accorded by the Vice Chancellor, on 25.07.2022, to implement aforesaid resolution of the Syndicate.

10. Orders are therefore issued, regularising the affiliation of the following self financing programmes, that have been already started, upholding UGC Regulations 2018, but without following the statutory provisions of the University at St. Joseph's College (Autonomous), Devagiri, Kozhikode, with effect from the academic year noted against each programme as detailed below, by implementing the Syndicate resolution:
